We the Convention Planning Committee do hereby propose as thus:

A: That Chapter Convention be held once every year in; To be announce accordingly ,

Branches that will hold the convention will be assigned in the order of branch formation or as may be agreed upon by the general house at the end of current convention.

Requirements for Chapter Convention:

(1) That all PDP branches that are hosting will provide entertainment and banquet dinner. And all found raised will be distributed 50% to the branch and 50% to chapters because prior to this division branches would have been given the option to either be assisted up front with \$2500, or be remunerated according to expenses argue, except for food and drinks All PDP Branches are mandated to buy an advert page on the Brochure and enable to remit such monies before the said convention since it will be part of the preparatory.

(2) All monies raised during the Chapter Convention will be distributed 80% to the Chapter and 20% to the Branch where Convention was hosted, as this is not a branch function but that of the chapter, except any donation from any Stakeholders invited by the Chapter to the convention goes to the Chapter purse.

(3) This pertains only to convections and conferences host by the chapter not the branches.

B: Chapter Executive Committee meetings: would be on Rotational bases among branches, would be held

quarterly, to be announced accordingly.

(1) All PDP branch will pay the sum of \$200. This will cover their brochure advertisement, entertainment and banquet dinner.

(2) All PDP Branches are mandated to buy a advert page on the Brochure.

(3) All monies raised during the Branch event will be distributed 50% to the branch and 50% to the Chapter prior this decision, the branch have been given an options to be remunerated up front with \$2,500.00 or be remunerated for all expenses argue during the event, with exceptions of feeding.

(4) Any donation from any Stakeholders invited by the Chapter to the convention goes to the Chapter purse.

(5) All Branches will be oblige to pay the above mandated fee even though their attendance May not be convenient , the participation of all members to convention is highly mandated as this is a one time a year function that would put a face to you and also give you an opportunity to voice your opinion .
